1. **Vocal Music Competition** on SRI PURANDARADASAR KRITHIS will be held as under:

2. You can submit the application forms ONLINE through our website www.spbs.in.
3. To open the application, please click the 4th icon from top at the right side of the home page of our website.
4. Please type your Telephone / Mobile Number and email ID correctly.
5. Once your application is successfully submitted, a registration number will be generated. Please quote that number in all your correspondence with us.
6. The application fee of Rs.150/- can be paid to our Bank account, the details of which is given hereunder:-

7. If you are not able to pay the application fee through online, the same will be collected on the date of preliminary competition. Please note that your participation to the competition will be confirmed only on receipt of application fee.
8. The applications can also be had by sending a request to spt7612@hotmail.com after remitting the application fee of Rs.150/-.
9. The tunes of the Krithis shall be strictly adhering to the Carnatic format with Pallavi, Anupallavi and Charanam. The western, folk and light tunes are not recognized. Change of song after submission of application will NOT be entertained.
10. The Competition will be conducted for the following **THREE** categories of participants.

Category	Age group	No. of songs	Duration (in minutes)
Sub Juniors	9 to 12 years	3 songs	5 – 10
Juniors	13 to 17 years	5 songs	5 – 10
Seniors	18 to 22 years	6 Songs	10 – 15

11. **Candidates, who render rare krithis will be awarded bonus marks.** Candidates are advised to bring their own Sruthi Instrument (with Batteries). Usage of Mobile phone for the purpose of sruthi is **NOT ALLOWED**. **All the participants are advised to come in Indian Traditional costume.**
12. The decision of the Judges shall be final and binding on each candidate. Canvassing in any form is strictly prohibited.
13. **TOP FIVE** candidates will be selected in each category to appear for Finals.
14. Candidates those who secured I PRIZE in last year's competition will not be eligible to participate in this year in the **SAME CATEGORY**. Concert performing Artists, irrespective of the age, are not eligible to participate.
15. The prize winners of the final competition in all categories will be given an opportunity to perform during the prize distribution function with suitable accompaniments.
16. Participation on the day of the competition will be on 'First come First served' basis.
17. **The last date for submitting the applications through online will be 1st August 2019.**
18. **An objective type written quiz contest in Music will be conducted to candidates selected for Finals. A separate prize will be awarded based on merits.**
